**“RAGGING IS COGNIZABLE OFFENCE AND IS BANNED  
IN ANY FORM INSIDE & OUTSIDE THE CAMPUS”**

<b>Ingredients/forms of Ragging</b>	<b>Punishments</b>
- Abetment to ragging;	- Cancellation of admission.
- Criminal conspiracy to rag;	- Suspension from attending classes and academic privileges;
- Unlawful assembly and rioting while ragging;	- Withholding/withdrawing scholarship/fellowship and other benefits;
- Public nuisance created during ragging;	- Debarring from appearing in any test/examination or other evaluation process;
- Violation of decency and morals through ragging;	- Withholding results;
- Injury to body, causing hurt or grievous hurt;	- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Wrongful restraint;	- Suspension/expulsion from the hostel;
- Wrongful confinement;	- Cancellation of admission;
- Use of criminal force;	- Rustication from the Institution for period ranging from 1 to 4 semesters;
- Assault as well as sexual offences or unnatural offences;	- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period;
- Extortion;	- Fine ranging between Rs. 25,000/- to Rs. 1 Lakh;
- Criminal trespass;	- Rigorous imprisonment upto 3 years.
- Offences against property;	- Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.
- Criminal intimidation;	
- Attempts to commit any or all of the above mentioned offences against the victim(s);	
- Physical or psychological humiliation;	
- All other offences following from the definition of “Ragging”.
